### WINE CLUB GENERAL CONDITIONS

#### ARTICLE 1 - OBJECT

The object of this document is to set out the membership conditions of a non-professional client (henceforth "Member") of the Château de la Crée Wine Club (henceforth the "Club"), managed by CREATRICE, a limited liability company governed by French law, with a capital of 500,000, based at Château de la Crée, 21590 Santenay, and registered with the Commercial Court of Dijon under No. 491 304 911 (henceforth the "Seller").

#### ARTICLE 2 - CLUB MEMBERSHIP

On joining the club, the Member can choose between several types of subscription, enabling him or her to benefit from priority allocations of wines and various advantages, as described on the application form.

A subscription is valid for a twelve-month (12) period and entitles the Member to receive two deliveries a year. Payment for the first delivery will be debited from the Member's credit card on joining the club. The second payment will be automatically withdrawn from the Member's account by credit card debit.

Club membership is a binding commitment to buying wine, as detailed on the application form. In the case of cancellation or non-payment of the second annual order, the Member will be liable for a cancellation fee of  $50\varepsilon$ .

The member must have at least the legal minimum age to purchase alcohol in his or her country of residence

#### ARTICLE 3 - APPROVAL

By virtue of the exemption from Article 1587 of the French Civil Code, the sale is considered binding and final without approval of the product by the Member, who waives the right to subject the purchase to prior tasting. This waiver of the right of approval does not preclude the Member's right to recur to legal guarantees regarding hidden defects and/or the legal guarantee of compliance, where applicable.

#### ARTICLE 4 - DELIVERIES

The Member may request deliveries to the following countries: France, Switzerland, Belgium, Germany, Italy, Luxembourg, Monaco, the Netherlands, Spain and the United Kingdom. The delivery charges for each country or zone are detailed on the application form. The exact shipping fee depends on the number of bottles ordered and the weight of the consignment, and will therefore be specified before each of the two annual deliveries. The delivery charges will be reviewed every year on 1st March to take into account any potential modification by the carriers.

SARL CREATRICE [CREATRICE LTD] does its utmost to deliver the goods ordered by the Member within the delivery times stated when the latter joined the club. Should the delivery not be made within thirty (30) days of the estimated delivery date, regardless of the cause of delay, except in cases of force majeure or a reason attributable to the Member, the sale may be cancelled on the written demand of the Member, pursuant to Articles L. 216-2, L.216-3, and L.241-4 of the French Code of Consumption. The amounts paid by the Member shall subsequently be reimbursed to the Member within the fourteen (14)

days following the end date of the contract.

It is the member's responsibility to check the goods delivered and report any potential reservation in the presence of the deliverer.

Without detriment to the provisions below on legal guarantees, the Member then has three (3) days from the date of delivery to inform SARL CREATRICE, by email or postal mail, of any reservation or complaint concerning compliance or an apparent defect noted in the goods delivered, attaching or enclosing any supporting document (especially photographs). After this period, and in case of failure to observe these formalities, the goods will be presumed compliant and free from any apparent defect, and no claim will be accepted.

## WINE CLUB GENERAL CONDITIONS

#### ARTICLE 5 - RIGHT OF WITHDRAWAL

Pursuant to the French Code of Consumption, the Memberhas fourteen (14) days with effect from the date of delivery of the wines to e xercise his or her right of withdrawal with the Seller, without needing to provide a reason or incurring any penalty, provided that the wines are returned intact in their original packaging within fourteen (14) days of notifying the Seller of the Client's wish to withdraw.

The goods must be returned, in their initial state and complete (with packaging, label, etc.) in such a way that they may be resold, to the following address:

The right of withdrawal may be exercised by means of the withdrawal form below, or by any other declaration explicitly stating the wish to withdraw.

If this right of withdrawal is exercised within the above-mentioned period, the sum reimbursed will be the sum of the wines purchased and the delivery charges; the return shipping costs will be borne by the Client and the goods will be transported at the Member's risk.

Reimbursement will be made within fourteen (14) days of receipt of the wines.

#### ARTICLE 6 - LIABILITY – GUARANTEE

SARL CREATRICE is liable for any non-compliance of the goods sold, pursuant to Article L. 217-4 and in line with the French Code of Consumption, along with the legal guarantee for hidden defects, as stipulated in Article 1641 and in accordance with the Civil Code.

Acting under the legal guarantee of compliance, the consumer:

Has a two-year period from receipt of the goods in which to act;

Can opt for the repair or replacement of the goods, subject to the price conditions stipulated in Article L. 217-9 of the Code of Consumption;

Is exempt from producing proof of non-compliance of the goods for twenty-four (24) months following receipt of the goods.

The legal guarantee of compliance applies regardless of any commercial guarantee granted. The consumer can choose to apply the guarantee on the hidden defects of the goods sold within the framework of Article 1641 of the Civil Code. In this case, he or she can opt for the cancellation of the sale or for a reduction in the sales price, pursuant to Article 1644 of the Civil Code.

#### ARTICLE 7 - RENEWAL AND TERMINATION

This contract is renewable by tacit agreement on its anniversary date for a new twelve-month (12) period. The Member is, however, entitled to terminate the contract by informing the Seller by email or postal mail with one month's notice. The Seller commits to informing the Member of the anniversary date two months in advance.

#### ARTICLE 8 - PERSONAL DATA

SARL CREATRICE, as data controller, handles the personal data provided by the Member on joining the club for the purposes of processing the order and informing him or her of commercial news regarding its goods and services.

Personal data will be kept for three (3) years with effect from the termination of the business relationship and will be used only by SARL CREATRICE and its contractors. The Member may, at any time, withdraw his or her consent by sending an email to hospitality@lacree. fr or by clicking on the Unsubscribe link at the bottom of each email.

# WINE CLUB GENERAL CONDITIONS

The Member's bank details will be kept securely, with the express agreement of the Member, for the duration of the subscription. This data will be deleted on the expiry date of the membership. The Member is entitled to access his or her personal data and demand the rectification of inaccurate data, the deletion or restriction of the processing of this data according to GDPR, or the portability of this data. Furthermore, the data subject may file a complaint with the CNIL (Commission Nationale Informatique et Libertés) [National Data Protection Commission], the monitoring authority in France.

ARTICLE 9 - APPLICABLE LAW / LITIGATION

These General Conditions are ruled by French law.

ANY LITIGATION ARISING FROM THE EXERCISE OF THESE CONDITIONS OR RE-LATED THERETO FALLS WITHIN THE EXCLUSIVE JURISDICTION OF THE FRENCH COURTS.
